- Once your place has been confirmed will we take your deposit of £100. Your deposit is refundable *only* if you have transferred a minimum of £1500 to the charity by 25.05.10. If you drop out for any reason your deposit is non-refundable.
- You must be 18 years or over on the day of the race.
- If you are unable to participate in the event for any reason, all donated monies collected in support of Whizz-Kidz must be forwarded to the charity or returned to the individual sponsors. Monies already received by the charity will not be refunded.
